Instructions

Each Kubb set, created by OutdoorFun101, is unique. Batons are cut from various species of local trees and are grouped in sets of six with similar uniform size. You will notice nature's imperfections with knot holes, bark and natural bends or curves. Each baton is sanded to remove excess stubble or network branches and hand-dipped with four coats of clear polyurethane. The King and ten Kubbs are crafted using ACR treated lumber for outdoor ruggedness and durability. The lines are measured and marked for easy set up.

Water Clarity Report

If you've been out enjoying the lake this summer, we hope you have noticed the almost complete ABSENCE of matting surface weeds this year as compared to previous years. Those mattings of weeds usually consisted of a combination of Curly Leaf Pondweed (CLP) and Eurasion Water Milfoil (EWM) - both of which are invasive species to Lake Sarah.

Our first "whole lake" CLP treatment this year was a great success. With volunteers from our lake community, we safely and cost effectively killed off all of the CLP lake wide - well before the CLP had a chance to form their "turion" seeds. Even better to share is that we had every shoreline owner in support of our treatment efforts and 87% of shoreline owners made a contribution of the suggested \$100 (or more). While this is a great 1st year accomplishment, we want to remind everyone that the sediment survey last fall confirmed an average of 1,100 turion seeds in each square meter of sediment - which explains why this will be at least a 5 year journey to gain full control of CLP.



As for Eurasion Water Milfoil (EWM), the other invasive species we want to control, we simply did not see enough EWM to warrant treating. We confirmed that other lakes in our area were reporting less EWM this year as well. While we can't fully EXPLAIN why the EWM didn't grow this year as it has in the past, at the same time you won't hear anyone COMPLAIN about the lack of EWM either!! Our summer weed inspections confirmed we have a healthy population of Coontail, a native species which we want to see replace CLP and EWM as it provides the cover and oxygen the fishery needs - with limited surface matting.

While CLP treatments are effective at reducing the internal loading of phosphorus in Lake Sarah, the larger source of phosphorus in our lake is attributable to external sources. We are pleased that the cities of Loretto and Medina teamed up last year to receive a grant and complete a water quality improvement pond project at the Loretto ball-fields. This will have a measureable effect on reducing both the sediment and phosphorus run-off into Lake Sarah from Loretto Creek. The City of Independence has also been active in applying for grants to help identify and complete projects that will reduce external phosphorus loadings. The City of Greenfield is currently in the process of approving a grant application that if successful could allow for the further analysis needed to determine the most cost effective improvement projects for reducing sediment and phosphorus run-off from Dance Hall Creek, which is the largest tributary flowing into Lake Sarah. Know that the LSIA will be actively working with all of our surrounding cities in promoting and/or partnering as needed to support cost effective ways to improve Lake Sarah's water quality.

WE NEED YOUR HELP TO IMPROVE WATER QUALITY!

The Pioneer-Sarah Creek Watershed Management Commission is leading a project to protect and improve water quality within the watershed. In order to tailor outreach for this project, the Commission is conducting a study to better understand the knowledge, needs, and concerns in our community about water quality. We would greatly appreciate your participation in the survey to help demonstrate to the watershed commission how important water quality is to Lake Sarah residents. Fishery Update: Walleye

In 2007 there were no walleyes included in the DNR survey taken, while in 2013 we had 9 walleyes caught as part of the same survey! The average weight of these walleyes was 2.21 pounds which is approximately 18 inches. The largest walleye caught was almost 23 inches!

Stocking Fish Sizes

<u>Fry</u> - Newly hatched fish that are ready to be stocked usually called "swim-ups". Walleye fry are 1/3 of an inch or around 8 mm.

<u>Fingerling</u> - Fingerlings are one to six months old and can range from a size of one to twelve inches depending on the species. Walleye fingerlings range from three to eight inches each fall.

<u>Yearling</u> - Yearling fish are at least one year old. A one-year-old fish can range from three to twenty inches depending on the species. Walleye yearlings average from six to twelve inches.

<u>Adult</u> - Adult fish are fish that have reached maturity. Depending on the species, maturity can be reached at two years of age. Walleye reach maturity between the ages of four and six years.



Water Level Report

In many respects 2013, turned out a lot like 2012. Plenty of rain and water coming into Lake Sarah in the spring time, then turning to drought conditions in the summer and early fall. Early this year (right after ice out) we had a lot of loose vegetation coming from the lake getting caught in Sarah Creek, that continued until mid July. In mid June-July beavers started damming Sarah Creek and their dams were removed 11 times. One of the biggest projects in 2013 was clearing trees that had fallen into Sarah Creek south of the TRPD dog park after the June storms that hit our area. So far this year volunteers



from the LSIA put in 66 hours of work as compared to 72 hours in 2012 and 180 hours in 2011.

Although a lot has been done in the last 3 years we still have some concerns:

1)Excessive cattail growth in the lake as well as Sarah Creek. In late August of 2012 a permit from the DNR was granted to LSIA to chemically treat a 300' long and 15' wide stretch from just south of the weir to just north of CP Rail culvert. This was accomplished with support from the City of Greenfield, TRPD, Pioneer Sarah Creek Watershed and a couple of volunteers from LSIA. The goal was to see if we could keep the creek from getting over grown with cattail and the results would show up in the year 2013. Well it turns out that our efforts were very successful and cost effective as well. The treatment cost about \$100 doing the work ourselves, and would have cost around \$2,400 based upon estimates from a couple of commercial applicators. We plan on continuing to do this as necessary.

- 2) Loose bogs.
- 3)Beaver dams.
- 4) Working with CP Rail to make sure culverts and their 50' of right of way is maintained.

I would like to thank the volunteers who helped this year: Joe Slavec, John Wise, Craig Smeby, Mike Peterson, Roger Van Beusekom, Brent Lau, Joe Baker and Matt Baker.
